IMM request a variation to allow for ongoing assessment of the following fisheries to continue against the requirements of the Fishery Assessment Methodology (FAM) (v. 1) until the time of reassessment, rather than implementing changes in the MSC Certification Requirements (CR) (v.1, August 15, 2011). At the time of re-assessment, the fishery will be assessed using the most recent version of the MSC Certification Requirements, and/or required documentation in place at that time.

Rationale/Justification

Given that the version 2.1 of the FAM was used to format the basis of the CR and CG released in August of 2011, and the substantive changes between Version 1.0 and Version 2.1 of the FAM, varying from the assessment tree used to certify the fishery would require additional resources to not only identify the changes between the assessment trees, but would also act as a 'moving' target for the fishery clients.

IMM will continue to assess the fishery against FAM v.1 which it was first certified against until the time of reassessment. At the time of reassessment, the fishery will be assessed against the most recent assessment guidelines in place at that time.

Implications for assessment (required for fisheries assessment variations only)

There are no significant implications to the fishery assessment if the variation request is granted, as it will allow the assessment to continue to be assessed under FAM v.1 which is was subject to during the initial certification.
