

Argentine anchovy (*Engraulis anchoita*), Bonaerense stock, semi-pelagic mid-water trawl net fishery

List of companies and vessels involved in the MSC Fishing Certificate

Organización Internacional Agropecuaria S.A. (OIA) is pleased to announce you that vessel's list was changed. Client group signed a general agreement with a new vessel (F/V ARGENTINO) in order to subcontract them to provide MSC anchovy stock Bonaerense since 2019 fishing period, using semi-pelagic mid-water trawl net. This vessel has the same fishing gear. There are no differences in mid-water trawl equipment, fishing methods and manoeuvres. The new vessel was identified as eligible in the re-certification process and listed in the first surveillance report (2018).

The impact in the ecosystem of vessel was reviewed on the component of Principle 2 in the re-certification process (2016). So, there is no reason to modify Principle 2 assessment and the impact is maintained.

OIA advised to client group that fish caught by F/V ARGENTINO after the publication date of this announcement can be considered as MSC Certified. Fish caught prior this date may not be considered as certified.
