Management System: Alaska pollock are managed under the authority of the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act, MSA), with management recommendations from the North Pacific Fishery Management Council (NPFMC) and implementation through the National Marine Fisheries Service (NMFS). Under the MSA, the NMFS must manage fisheries to maintain optimum yield (OY) by rebuilding overfished fisheries and preventing overfishing.

Chain of Custody: All of the Gulf of Alaska pollock is processed onshore. Chain of custody for unprocessed onshore landings starts upon landing to a processing facility.
