Her research and publications are in the area of marine economics and policy, with an emphasis on fishery management, ecosystem-based fishery management, property rights and institutional design. Dr. Hanna has served as a scientific advisor to the U.S. Commission on Ocean Policy, National Oceanic and Atmospheric Administration, National Marine Fisheries Service, Minerals Management Service, Northwest Power and Conservation Council and the Pacific Fishery Management Council. She served on the Ocean Studies Board of the National Research Council (NRC), National Academy of Sciences, and several NRC Committees, including the Committee to Review Individual Quotas in Fisheries and the Committee on Protection and Management of Pacific Northwest Anadromous Salmonids.

MRAG Americas, Inc. is pleased to announce that a Marine Stewardship Council (MSC) assessment of the **California and Washington pink shrimp** fisheries has begun. The assessment will evaluate the fishery for compliance with the MSC's Standard for well-managed and sustainable fisheries. MRAG Americas has determined that the fishery is in scope.

This fishery assessment will be undertaken by way of an expedited scope extension to the certified Oregon pink shrimp fishery. As part of the assessment, MRAG Americas announces that the MSC assessment of the California and Washington pink shrimp fisheries will undertake stakeholder meetings and assess relevant documentation with a visit to the fisheries in March, 2015. The assessment team will meet at the Hatfield Marine Science Center in Newport Oregon from March 9th-11th, in conjunction with the 2nd surveillance audit of the Oregon pink shrimp fishery. The purpose of these meetings is for a fishery assessment and stakeholder consultation to receive information from fishery representatives, government management agencies, non-governmental organizations, and other interested stakeholders

MRAG Americas announcement—expedited MSC assessment of the CA and WA pink shrimp fisheries

Because this is an expedited scope extension assessment, the assessment will examine components of the California and Washington fisheries not held in common with the Oregon fishery. The components to be assessed for the WA and CA fisheries are as follows:

- Principle 1 Harvest Strategy
- Principle 3 Governance and Policy
- Principle 3 Fishery Specific Management

In addition, it may be necessary to assess any differences in management Performance Indicators in Principle 2.

MRAG invites stakeholders to provide any information considered relevant to the surveillance and expedited assessments of the fisheries. MRAG will schedule meetings with stakeholders if requested. To schedule a meeting please provide:

- your name and contact details
- your association with the fishery
- the issues you would like to discuss
- where and when you would like to meet

Stakeholders may provide input at any time. We ask stakeholders who wish to meet with the team to make the request for a meeting by 5pm PST on 27 February 2015.
