Only yellowfin, bigeye and skipjack tuna UoAs that are certified and caught in the manner defined in the Unit of Certification under restrictions detailed throughout the body of the final Public Certification Report for this fishery, shall be eligible to enter the Chain of Custody at point of landing (E.g., when transhipped to reefer vessels, refrigerated containers or directly unloaded to a cannery). All AGAC members/vessels listed on the MSC track-a-fishery webpage are eligible to land MSC certified product. Chain of Custody must commence following the point of landing. As CoC commences from landing, CoC will be required from that point onward including all reefer vessels, transport, storage and processing facilities from when landing of fish occurs. All this takes place at the nominated point of landing (see below) and is no earlier than the change of ownership of the product (7.9.2.1.a, MSC FCP v.2.1). At this point the product shall be eligible to carry the MSC logo (under restrictions imposed by the MSC Chain of Custody standard). There are no restrictions on the fully certified product entering further chains of custody.
