Det Norske Veritas (DNV) is pleased to announce that we will be conducting the third Surveillance Audit for the Norwegian North East Arctic and North Sea Saithe fisheries.

The key purpose of the surveillance audit is:

- to review and evaluate the progress of the fishery against Conditions of Certification raised during the full assessment
- review any changes in the management systems
- review changes or additions / deletions to regulations
- review any personnel changes in scientific staff, key management or industry to evaluate impact on the management of the fishery
- review any potential changes to the scientific basis of information

The surveillance audit meetings will be held in Oslo and Bergen (Norway) during week 20 (19th & 20th May 2011) and will be conducted by Stephen Lockwood, member of the original assessment team and DNV Lead Auditor Ms. Sandhya Chaudhury.
