1. D.G. (Don) Parsons - Principle 1 & 2:

Don Parsons is a retired research scientist from Fisheries and Oceans Canada, Newfoundland Region. He has a M.Sc. in Biology from Memorial University of Newfoundland. Mr. Parsons has been the Principle Scientific Investigator for the biology, ecology and population dynamics of northern and striped shrimp (Pandalus borealis and P. montagui) and fisheries research in the Newfoundland and Labrador Region from 1978 through to 2005. He has been a member of the International Commission for the Exploration of the Seas (ICES) Pandalus Working Group (and subsequent Study Group) as well as a scientific advisor for the Northern Shrimp Advisory Committee (NSAC) in eastern Canada. He has represented Canada at various other international fora on Pandalus species and has published extensively on the biology and population dynamics of northern prawn.
