	MRAG Americas proposes to allow P3 team member, Bob Trumble, participate in the initial assessment audit from a remote location (his home) due to personal circumstances prohibiting his travel. He would participate in all parts of the audit visit via teleconference, except the dock visit.

	Personal circumstances have arisen that prohibit this team member from travelling away from his home. As this has happened at short notice, and he is still the best person for this team, we have determined the best course of action is to keep him on the team and request remote participation in the assessment visit.

5	If a fishery assessment, mitigation of the implications for assessment			
	MRAG Americas have assessed the risks to this assessment due to this variation as minimal. The team leader and P2 team member (Amanda Stern-Pirlot) will be on-site, with Dr Trumble participating as P3 team member remotely. This is logistically easy due to only a one-hour time difference and available telecommunications technology. Both individuals are very experienced MSC assessment team members and team leaders, with a long track record of well-conducted site visits involving in-person and remote participants. In addition, Dr Trumble was the lead and P3 team member for the pre-assessment for this fishery which was completed very recently. As part of that process he has become very familiar with the fishery and has already spoken with or otherwise communicated with several of the individuals we will be interviewing during the site visit. Dr Trumble has also demonstrated on numerous occasions his ability to carry out rigorous, well-structured interviews during remote audits for several fisheries. The team leader will be present in-person during the site visit and present for the visit to the fishery's dock where traceability topics will be covered, which are the team leader's responsibility in this assessment, and for which she is qualified.
