## Acoura position on availability and proposed rescheduling of matters relating to the objection to certification of the North Sea Brown Shrimp fishery

Acoura acknowledge the objection to the certification of the North Sea brown shrimp fishery and the acceptance of the same by the IA on 22 Aug 2017.

Acoura have now had the opportunity to ascertain the availability of the assessment team and head office staff. Due to prior commitments the team only have availability on 20, 28, 29 Sept.
