AUSTRALIAN TOOTHFISH AND MACKEREL ICEFISH FISHERIES ANNOUNCEMENT of ANNUAL SURVEILLANCE AUDITS

The Australian Toothfish fishery at Macquarie Island and at Heard Island and McDonald Islands were certified under the MSC standard in 2012; this will be their second surveillance audit. The Australian Icefish fishery at Heard Island and McDonald Islands was certified in 2011 and this will be the third surveillance audit for this fishery. The annual audits will take into account recent developments and monitor progress on the conditions placed on the fishery for continued certification.

The surveillance team from SCS Global Services (SCS) will be conducting meetings in Hobart, Australia on the **24-25 July, 2014**. SCS invites all stakeholders to meet with the team and bring forth any issues or concerns about the continued certification of this fishery. The meeting will include participants such as fishery managers, scientists and stakeholders to gain a full understanding of the current state of the fishery.
