### Exmouth Gulf Prawn Trawl Fishery

**Management System:** The fishery is managed by the Western Australia Department of Fisheries through a combination of input controls (limited entry, seasonal closures, gear restrictions and operational controls), implemented under the Fish Resources Management Regulations 1995 and the Exmouth Gulf Prawn Limited Entry Fishery Notice 1989.

**Chain of Custody:** All MG Kailis prawn trawlers fishing from Exmouth in the EGPMF, off Australia's west coast will be eligible to be covered by the MSC fisheries certificate. From the time that the product leaves the vessel until at least the first point of shipment or sale, the product is handled on a box in-box out basis. COC starts after the first point of sale from the client group, or at the first point of repackaging, secondary processing or sale to the general public, whichever comes first. The extent of the fishery certification is to the point of landing of fish at ports where recording, verification and sampling of landings takes place. The ports of landing are restricted to Exmouth and Fremantle.
