

The point(s) at which fish and fish products may enter a chain of custody:

Landings will be made primarily at Harlingen and on occasion to other Dutch, German and Danish designated ports, (namely Urk, Cuxhaven and Bremerhaven).

Ultimately all certified fish will pass through the sales system at Urk fish market. The certified fish remain the property of the individual vessels fishing under Osprey Trawlers Group BV until sold on the Urk fish auction.

There are no Inseparable or Practically Inseparable (IPI) stocks in this fishery.
