MSC Year 1 Surveillance – Pan Pacific yellowfin, bigeye and albacore longline fishery

Control Union (UK) Ltd. (CU UK) would like to inform stakeholders that CU UK has been in discussion with the client (Dongwon Industries) and have agreed to apply the 6-month extension available within the MSC process of the anniversary date for the above surveillance audit.

25th December is the anniversary date of the fishery, and the audit will now take place after this date as a result of the client/assessor availability, ongoing difficulties in organising the audit due to the COVID-19 pandemic and to align with the publication/outcome of the WCPFC commission meeting relevant to all the UoAs.
