

# Change to assessment team membership

# SZLC, CSFC & FZLC Cook Islands EEZ South Pacific albacore, yellowfin and bigeye longline

Control Union UK Ltd (CU UK) would like to inform stakeholders of changes in the assessment team for the above fishery. Dr Deirdre Duggan will be joining the SZLC, CSFC & FZLC Cook Islands EEZ South Pacific albacore, yellowfin and bigeye longline MSC assessment team for the Year 1 surveillance audit and will be attending the remote site visit on the 5th of April 2022. Deirdre will take responsibility of traceability for this assessment.

Before joining CU UK, Deirdre worked with LRQA as Fisheries Manager, where she was responsible for the implementation of the MSC assessments as well as establishing LRQA activities related to the RFVS and Marin Trust. Prior to working on the CAB side of certifications, Deirdre gained experience on the client side working with an Indonesian NGO (MDPI), whose focus was improvements and recognition for small-scale Indonesian fisheries. As Program Director for MDPI, she led activities related to FIP implementation, traceability developments, Fair Trade and MSC certification of small-scale fisheries. Deirdre was also a consultant to IPNLF, developing a prototype policy scorecard for handline and pole and line fisheries. She was on the Steering Committee for the Asia-Pacific FIP Community of Practice 2019 workshop, on the Fair Trade Fisheries Advisory Council as well as the MSC Fish For Good council in Indonesia.

Deirdre obtained a PhD from Queen's University Belfast in 2014 (Fisheries Management), an MSc from Plymouth University in 2010 (Applied Marine Science) and a BSc from NUI Galway in 2008 (Marine Science). She is fluent in French, with a working proficiency in Bahasa Indonesia. Deirdre currently works as a Senior Fisheries Assessment Manager for CU UK. She has completed her MSC online training for CoC (2019 versions) and Fisheries (2020 versions), including Traceability (2020 version). Deirdre has no conflicts of interest for this fishery.

Chrissie Sieben will continue to be responsible for Principle 1, Beverley O'Kane for Principle 2 and Dr Charles Daxboeck for Principle 3. All three will join the remote site visit.
