Management System: The fishery is managed by the Federal Agency for Fisheries SVTU, regional divisions of Federal Agency for Fisheries. Regional (Kamchatka) Fisheries Research Institute, KamchatNIRO. Regional (Russian Far East) Fisheries Research Institute, TINRO-Center. All Russia Fisheries Institute, VNIRO. SevvostRybvod.

Chain of Custody: Chain of Custody begins at the first instance of delivery of salmon to a processing facility in the client group or at a point of change in ownership of the fish. Members of the Client Group own the fish they catch, commencing at the point of fish catch. Should other companies share the certificate at some point and sell fish to VA, Delta or other company holding chain of custody, chain of custody would start at the point of sale, but no later than delivery to a processing plant. To use the MSC logo, subsequent links in the distribution chain must enter into a separate chain of custody certification that proves they can track the salmon product to a chain of custody holder.

This certificate certifies pink and chum salmon for Sea of Okhotsk and Ozernaya, Koshegochek, Golygina, Opala, Kol, Vorovskaya and Pymta Rivers, sockeye for Ozernaya rivers only and coho salmon for the Kol River only.
