1 Proposed variation

A VR was accepted on the 14/12/22 granting an extension to the ACDR announcement period by 2 months; LRQA is requesting to further extend the ACDR announcement period by 1 week.

2 Additional time requested (where applicable)

3 Justification

The justification for a further weeks extension is twofold:

- 1) The P3 assessor's availability for this re-assessment, and thus their ability to commit to timeframes, has been severely challenged by personal circumstances beyond their control.
- The P2 & TL for this assessment is heavily involved in the early adoption of Section SE proceedings; given recent progress and increased capacity this role has demanded, TL oversight of the report has been delayed too.

The deadline for announcing the reassessment for this fishery currently stands as the 19th of February 2023. An initial VR was submitted and accepted on this requirement in order to allow time for the ACDR to be prepared at a standard acceptable by the CAB and client, delayed by outputs of a recent objection to scope extended elements. A further VR against this requirement is now sought to allow time for the ACDR report to be prepared. This would give a new announcement deadline of 26th of February 2023, further extending the deadline by one week.

- 4 Implications for assessment
 - As the ACDR delivery is delayed, LRQA anticipates there is a chance the reassessment may not be finalised by the certificate expiry date.
- 5 Mitigation of the implications for assessment

LRQA will seek to deliver the ACDR as expeditiously as possible, as well as successive reporting stages (observing all consultation periods accordingly), in order to prevent further timeline delays.

6 How many conditions does the fishery have?

The existing certificate currently has six open conditions, the progress/delivery of which is not expected to be impacted by this delay.

- 7 What is the status of the current assessment or audit?
- The existing certificate for the PNA Tuna Fishery covers skipjack tuna and yellowfin tuna in free school sets. LRQA is in the planning stage for re-assessment, which is yet to be announced, but will cover catches in all set types as required under FCP v.2.27.5.2 / 7.5.3.
- 8 Other relevant information

The P3 for this assessment has experienced a recent personal/familial emergency, and has only just returned from bereavement leave.
