Client/Certificate Holders: Danish Fisherman (DFPO) and Danish Pelagic Producer Organisation (DPPO)

Management System: The European fisheries are managed through the European Union Common Fisheries Policy (CFP). The activities of the DPPO and DFPO vessels like similar vessels across the European Union, are tracked by satellite, and their catches and landings are monitored through logbook declarations, at-sea and on-shore inspections. The principal EC Regulations relevant to the sandeel, pout and sprat fisheries are those that set the Total Allowable Catch and Quota for fishing fleets, specify technical restrictions for fishing activity, and restrict fishing to encourage the recovery of the depleted stocks.

Chain of Custody: Only North Sea and Skagerrak sandeel, sprat, and Norway pout caught by DFPO and DPPO-registered vessels in the manner defined on this certificate shall be eligible to enter the Chain of Custody (CoC). Chain of Custody begins at landing (either directly to processing plant, or through separated overland transportation to the plant), at which point the product shall be eligible to carry the MSC logo. There are no restrictions on the certified product entering further chains of custody. The DFPO/DPPO Danish sandeel, sprat, and Norway pout fishery does not require its own CoC certificate.
