PCDR stakeholder period extension

Early Application of Section SE - WCPO yellowfin, bigeye, skipjack and South Pacific albacore

Control Union (UK) Limited (CU UK) has received a request from a stakeholder for an extension to the Public Comment Draft Report period for the Early Application of Section SE WCPO yellowfin, bigeye, skipjack and South Pacific albacore. The initial deadline for this consultation was 17:00 UTC on 30/11/2023, under MSCs clause D1.2.29 this has been now extended to 22nd December 2023 at 17:00 UTC.
