Richard currently works as an advisor to FFA, MFMR, and PNA as an offshore tuna advisor. Richard is an economist and fisheries management and policy programming specialist having worked on similar issues for international agencies, Commonwealth and State Fisheries. Richard holds a bachelor degree in Fisheries Economics and a Masters in Agricultural Economics from the University of Portsmouth, and Imperial College, London, respectively.

In addition, he has undertaken review of fisheries assessed under the World Wildlife Fund Common Wild Capture Fishery Methodology. Previously as a Senior Fisheries Scientist with the Bureau of Rural Sciences he has engaged in a wide range of international and domestic fisheries management and policy. Kevin represented BRS on many committees and groups such as Australian Fishery Management Authority fishery assessment groups (including for the Southern and Eastern Scalefish and Shark Fishery, the Northern Prawn Fishery, the Bass Strait Scallop Fishery, and the Western Tuna and Billfish Fishery),

In 2006 he chaired the meeting of the Working Party on Billfish led Australia's delegation during 2 weeks of scientific meetings of the Commission for the Conservation of Southern Bluefin Tuna in Tokyo. In 2008, he represented Australia at a meeting to progress the Regional Plan of Action to Promote Responsible Fishing Practices including Combating IUU Fishing in Bangkok and presented Australia's cooperative approaches with Indonesia to research and manage shared snapper stocks in the Arafura/Timor Seas. MRAG Americas, Inc. is pleased to announce that a Marine Stewardship Council (MSC) scope extension of the Blue Endeavour prawn to the certified Exmouth Gulf prawn fishery has begun. The assessment will evaluate the fishery for continued compliance with the MSC's Standard for well-managed and sustainable fisheries. MRAG Americas has determined that the fishery is in scope.

This fishery assessment will be undertaken by way of an expedited scope extension to the certified Exmouth Gulf prawn fishery. As part of the assessment, MRAG Americas announces that stakeholder meetings and assessment of relevant documentation will be undertaken with a visit to the fishery in February, 2018. The assessment team will meet in **Perth, Australia on the 20<sup>th</sup> – 22nd of February, in conjunction with the 2<sup>nd</sup> surveillance MRAG Americas announcement—Exmouth Gulf blue endeavour scope extension** 

of the Exmouth Gulf prawn fishery. The purpose of these meetings is for a fishery assessment and stakeholder consultation to receive information from fishery representatives, government management agencies, non-governmental organizations, and other interested stakeholders.

Because this is an expedited scope extension assessment, the assessment will examine components of the Blue Endeavour prawn not held in common with the Exmouth Gulf prawn fishery. The components to be assessed for the Blue Endeavour prawn scope extension are:

- Principle 1 Outcome
- Principle 1 Harvest Strategy

MRAG invites stakeholders to provide any information considered relevant to the expedited assessments of the fishery. MRAG will schedule meetings with stakeholders if requested. To schedule a meeting please provide:
