All licensed fishermen who are members of, or who have a cost-sharing arrangement with Hjälmarens Fiskareförbund may supply product into further certified chains of custody. Details of fishermen included within the fishery certificate are available on the website http://www.insjorfiskare.se

Eligible points of landing are all landing points on the shores of Lake Hjälmaren.

Change of ownership, and the point from which Chain of Custody certification is required, is the first point of sale of pike perch from identified fishermen.

All processors/retailers/restaurants/fishermen etc. wishing to sell Lake Hjälmarens pikeperch as 'MSC Certified' will require their own separate Chain of Custody certification.
