1	Proposed variation		
	The current certificate expiration date is 23 April 2022. We propose to extend the certificate expiration date 30 days to 23 May 2022.		
2	Additional time requested

3	Justification		
	Due to the ongoing Covid-19 pandemic, there were some delays in information gathering post-site visit writing and scoring activities. The Public Comment Draft Report will be published March 2022. The additional amount of time requested would allow for the process requirements to be fulfilled while keeping the fishery certified.		
4	Implications for assessment		
	By extending the certificate expiration date, the fishery will be allowed to continue to sell their product as MSC certified. We note that if the certificate is allowed to lapse before the current assessment is completed, product will still be eligible but there will be a short period of time where it would once again be UMAF product, which would cause issues in the supply chain. This would be avoided by this short certificate extension. We note that the season for market mussels begins in earnest in the summer, so the new certificate, if successful, will be in place before a large volume of new product enters the supply chain.		
5	Mitigation of the implications for assessment		
	There are no implications for the assessment, except that there will be slightly more time to complete it without a certification lapse.

	There are no open conditions on this fishery, though the reassessment assigns one new one. A slight certificate extension has no bearing on this situation,
