3	Justification			

The Bay of Fundy, Scotian Shelf and Southern Gulf of St Lawrence lobster trap fishery has been combined with the Prince Edward Islands lobster trap. The new fishery resulting from that merging is the Maritime Canada inshore lobster trap fishery which is currently under re-assessment.

There has been substantial delay in the re-assessment process as follows:

- For the Scotian Shelf and Bay of Fundy UoAs, the condition on PI 1.2.2 HCRs & Tools has been carried over in the re-assessment with a revised milestone set during the 3rd surveillance audit to have well-defined HCRs adopted and therefore the condition closed before the publication of the PCDR. DFO Maritimes's initial timeframe for approval and implementation of the well-defined HCRs was March 2020. However, due to the covid-19 pandemic, DFO Maritimes' work plan for the adoption of well-defined HCRs has been delayed and HCRs have finally been adopted and implemented end of July 2020 for UoAs 4 and 5.
- SAI Global was advised in July 2020 that the Principle 3 assessor was no longer available to be part of the assessment team. SAI Global needed time to find a new Principle 3 assessor and a notification of change in the assessment team was published on 6th August 2020. Also, SAI Global allowed time to the new Principle 3 assessor to review the draft report and make amendments if necessary.
- As a consequence of the 2 points above, the CPRDR was made available to the client and the Peer Review College on 11th September 2020.
- \bullet The client's and the peer reviewers' comments were provided on 13 th October 2020 and 16 th October 2020; respectively. The assessment team needed time to address these comments.

Although, the lobster fishing season is currently closed in the Southern Gulf of St Lawrence (UoAs 1 and 2), the lobster fishing season is currently open in a portion of the Easter Scotian Shelf (UoA3), in the Southwest Scotian Shelf (UoA4) and in the Bay of Fundy (UoA5). Note that the lobster fishing season in the Southern Gulf of St Lawrence is due to open in spring 2021, the re-assessment is scheduled to be completed by that time.

	The PCDR is scheduled to be published on the week of 2 nd November 2020.			
	Therefore, stakeholders' comments on the PCDR should be received no later than 6^{th} December 2020.			
	The Final Report & Determination is expected to be published before the Christmas break. Taking into account			
	the Bank Holidays, the end of the objection period is expected to be in the 2 nd or 3 rd weeks of January 2021.			
	The PCR should be available end of January 2021/early February 2021.

	If the certificate extension was to be granted, it will allow the fishery to be still covered by a valid certificate			
	during the whole re-assessment process. It means that the client group will not be penalised by the delay that			
	occurred for the reasons described above including covid-19 pandemic related delay.
