Management System: Management of the coastal Pacific hake fishery is shared among the Joint Management Committee (or JMC, as established by the Agreement Between the Government of Canada and the Government of the United States of America on Pacific Hake/Whiting), who recommends the annual TAC, and the National Marine Fisheries Service (NMFS) in the US and the Department of Fisheries and Oceans (DFO) in Canada.

Chain of Custody: This fishery certification has evaluated the Chain of Custody to the point of first landing at shoreside or transfer at sea. Chain of custody certifications will be required for the motherships, catcher/ processor vessels, and shoreside processing operations. Catcher vessels (including Makah Tribal catcher vessels) providing raw product to either the mothership sector or shoreside will not require chain of custody certification.
