**Management System:** The fishery is managed by the Federal Agency for Fisheries; Regional divisions of Federal Agency for Fisheries, SVTU; Regional (Kamchatka) Research Institute for Fisheries and Oceanography, KamchatNIRO; Regional (Russian Far East) Research Institute for Fisheries and Oceanography, TINRO-Center; All-russia research Institute for Fisheries and Oceanography;hy, VNIRO; North East Basin Administration for Fisheries and conservation of Aquatic Biological Resource, SevVostRybVod.

**Chain of Custody:** Chain of Custody begins at the first instance of delivery of salmon to a processing facility in the client group or at a point of change in ownership of the fish. Members of the Client Group ("Narody Severa" and "Bolsheretsk") own the fish they catch, commencing at the point of fish catch. Should other companies share the certificate at some point and sell fish to "Narody Severa", "Bolsheretsk" or other companies holding chain of custody, chain of custody would start at the point of sale, but no later than delivery to a processing plant. To use the MSC logo, subsequent links in the distribution chain must enter into a separate chain of custody certification that proves they can track the salmon product to a chain of custody holder.
