### Marine Stewardship Council surveillance postponement.

Dear Stakeholder,

RE: MSC Site Visit postponement for the Tristan da Cunha Rock Lobster fishery due to Coronavirus outbreak.

Control Union Pesca Ltd. (CU Pesca) would like to inform all stakeholders, that due to the recent global spread of coronavirus and the government policies regarding non-essential travelling, the site visit scheduled for Tristan da Cunha Rock Lobster fishery has been postponed.

MSC response to the COVID-19 pandemic was formalised in an official announcement from the MSC on 30<sup>th</sup> March 2020.

• All MSC certified fisheries are being given an automatic six-month certificate extension. Conformity Assessment Bodies (CABs) have been told to extend deadlines for all associated processes, including assessments, conditions, action plans and milestones. Fisheries can choose to continue their current process by arranging remote audits with their CAB, where feasible. The exception is expedited audits and objections, which need to continue to protect fish stocks and maintain confidence in our program, and further guidance on these two processes will be published shortly.

The new date of certificate expiry for the fishery is 14th June 2022. As per G7.28.8.1 this email informs you that the next surveillance is proposed to be held later than the certificate anniversary date of 14th June 2020 and will be held within the 6 month flexibility of the certificate anniversary (FCP 2.1 - 7.28.8.1) 14th December 2020. Further details on the new proposed surveillance audit in 2020 will be announced by CUP once government and MSC advice with the Covid-19 outbreak is further developed.
