## The point(s) at which fish and fish products may enter a chain of custody:

The North East Arctic haddock *(Melanogrammus aeglefinus)* product certified as sustainable in this assessment must only be landed to the following NEAFC registered ports:

Russia: Murmansk

Norway: Tromso, Kirkenes, Hammerfest, Allesund, Batsfjord, Honningsvag

Netherlands: Ijmuiden, Velsen-Noord

**UK:** Grimsby

Landings into any other ports, either by the fishing vessel or the transhipment vessel – including into China or other NEAFC ports not specified above – are NOT covered by this certificate, therefore any product landed by this route ceases to be certified as sustainable and is not eligible to carry the MSC logo.

In exceptional circumstances the fleet may be forced to land into other ports than those listed above and this must be into a NEAFC port in the EU or Norway. The client should notify Lloyd's Register at the time of the surveillance audit of the quantity and reasons for such exceptional landings.

The parties, or categories of parties, that are entitled to use this certificate to enter fish from the certified fishery into certified chains of custody:
